#### **Introduction**

This briefing paper prepared for Members and dated 12<sup>th</sup> October 2023 is in response to the consultation paper issued by the Department of Environment, Food and Agriculture and titled 'Public Consultation in relation to Town & County Planning Act Amendments, Definition of Development Order & Registered Building Regulations'. The closing date for responses is Friday 27<sup>th</sup> October 2023.

Below are the proposed responses to the questions asked on behalf of the Authority:

Question 1 - Do you think the policy intentions described are appropriate? (Please give reasons for your answer)

Yes.

It is believed that amendment CJ will reduce/prevent the possibility of misinterpretation of the Permitted Development Order, and therefore potentially reduce future disputes and administrative work required regarding retrospective applications.

Amendment CK will provide a higher level of scrutiny for applicable applications, however, this amendment could potentially be seen as an additional level of bureaucracy of an already (at times) excessively complicated administrative procedure.

Amendment CL will allow Government more time to bring forward proposals, which usually include infrastructure improvements which can be protracted to implement. This change should also allow for potential changes in Tynwald Membership and the associated changes in priorities for these Members during their terms.

Question 2 – Do you think the proposed amendments set out in the draft Bill will achieve the policy intentions set out above? (If not please give reasons)

Yes.

Question 3 - Do you think the transitional provisions are adequate? (Please give reasons for your answer)

Yes.

Prior to the implementation of the Bill the provisions will assist with the following:

- No period where historical buildings could be demolished;
- Properties from being demolished and sites left undeveloped for extended periods of time;
- Reduce the need for unnecessary planning applications;
- Bringing the Area Plan for the East in line with the other area plans.

Question 4 - do you think the proposed approach and scope of the Definitions of Development Order is appropriate? Please give reasons for your answer

Yes.

This approach to definitions should create less confusion when applicants or their agents are proposing to undertake works. This should also reduce the number of unnecessary planning applications being submitted, therefore freeing up planning resources.

Question 5 - do you have any detailed suggestions for matters to be included/addressed?

No.

Question 6 – do you think the proposed approach and scope of the updated Registered Buildings Regulations is appropriate? Please give reasons for your answer.

Yes.

This approach will provide more clarity for applicants or their agents when applying to undertake works. Additionally, those looking to access information about properties will be able to obtain the information more easily.

### Proposed Diversion of Public Right of Way No.148, Onchan

I am writing to give notice that the Department of Infrastructure is proposing to make an Order, Highway Diversion (Public Right of Way No.148, Onchan) Order 2023, the effect of which will be to divert a section of Public Right of Way No.148 near Ashley Park, Onchan.

Public Right of Way (PROW) No.148, Onchan, runs from Ashley Road to Ashley Park. The Department is satisfied that a part of the existing PROW should be diverted for the purpose of providing a more commodious route for users of the highway.

The Order is necessary due to the building of the Ashley Park Estate. The development has made it impossible to walk the final 83 metres at the southern end of the PROW. The Order creates a diversion of the PROW, creating two new routes which exit onto Ashley Park.

In order for the Department of Infrastructure to divert a public highway the legislation as set out in the Highways Act 1986 must be adhered to. Notice must be published in a local newspaper, and copies of the notice put on the highway to be diverted under the order.

The legislation states that notice must be served on the local authority, the owner, lessee and occupier of the land affected by the diverted highway and any statutory undertakers having apparatus under, in, upon, over, along or across the highway.

Please accept this letter and the attached documents as the notice required to be served by the Highways Act 1986 Schedule 3. The commencement date of this notice is Friday 06 October 2023. Allowing for the required 28 day notice period the expiry date for the notice will be Friday 03 November 2023.








#### **Dear Commissioners**

The Government Conference took place, and on the afternoon of 21st September 2023 the focus was on Housing – A Model for the future. A summary of my notes is detailed below, please note that these are not exhaustive, and are purely my own notes which are not verbatim.

Dave Tolson Partnership Group (DTP) did a presentation. They stated that they had been contracted by the Department of Infrastructure (DOI) to undertake a Housing Stock Options Appraisal in support of the 5 reports they had originally undertaken in 2013 – consideration of Housing Association (HA) options for the Island.

#### 5 options were presented:

- 1. HA standalone
- 2. HA standalone with HA and Local Authorities (LA) (of suitable note)
- 3. HA partnership with DOI and UK based parent HA
- 4. HA partnership with DOI HA and LAs and UK based parent HA
- 5. Regional bodies (4+1) model.

#### It was stated:-

- the purpose was to enhance and expand housing services for social housing.
- target is to build 250 affordable housing units per annum over 5 years.
- assets and liabilities would be transferred.
- Where joining with a UK parent HA there would be autonomy for the Board of the new HA.
- With a partner HA form the UK, operating over 2 legalities.

**Regional** - 4+1 model, North, South, East, West with Douglas kept separate. Opportunities and costs savings for sharing of services, procurement, etc.

**Option 1 -** This was the preferred option to hit the key objectives. This would put all DOI housing stock into the HA and anything else going forward would be moved in to the new HA.

It was commented that a wider consultation would be required and a more detailed examination.

During the Question and Answer session, a question was asked about transferring their DOI stock to the other bodies and then there would be no need to have a separate HA. However, the general response from the panel seemed to be that a HA was needed to move housing forward.

Comments from the panel were as follows:

- Acknowledged that there was a good relationship with the housing professionals in Local Authorities, with a lot of experienced people who can add value to a Board of a HA.
- That HA as an Island solution perhaps would fail.
- HAs were a way to modernise housing on the IOM. The DOI has to be stepped forward as they have 1,200 properties, and this is was the quick start. Then consider whether there it be widened out.

- Would have to consider the financial model and rents. Budget and Project Plan would need to be explored to move to the next step.
- The HA would involve all experts on the Island.
- DOI has to be stepped forward as they have 1,200 properties.
- There was a supply and demand problem, where does public sector housing fit in with that model.

Representative from Jersey stated that HA works well, with the sole purpose of delivering homes and look after those who live in them. They deliver in to the communities, with employment, and the HA develops and works alongside the communities.

#### Panel:

- Housing Associations came to the front during Tolson review 12 years ago and nothing has happened.
- Housing Associations are dynamic, flexible and we cannot deliver the solutions currently as we are not tooled up to deal with it.
- The Housing Associations are about changing, loans and repurpose.
- HA's about structure, there is no reason why they cannot offer other housing models of sheltered housing, care leavers, etc.
- There is a housing crisis and all housing providers in all jurisdictions are under pressure.
- Fixed term tenancies are to encourage the tenants to make choices.

Looking for a wider review, consultation not factored in but possibly around February 2024, with implementation within 24 months.

The Manx Development Corporation as a body are not interested in housing management, their contribution to urban and brownfield regeneration would be transferred to DOI or LA.

In answer to question DTP stated that LA public sector housing is more significant than UK due to the social housing stock assets being transferred to HA's. Non-related housing assets (e.g. shops above flats) would also be transferred.

Currently there is a review being undertaken within DOI, and gives an opportunity to do housing under a HA.

Further consultation, would be 2 stages, engage with tenants and engage with housing authorities. It is vital that people using the homes also have a voice.

Public sector housing would remain in the tax payers control, with such a valuable asset there would have to be transfer agreement agreed.

DOI team deliver a good service, but the structure in government is slow, by time approved, the service has moved forward. HA is more diverse, and commercially operated, and would have focus purely on housing.
