The Acting Chief Executive/Clerk took the chair for the commencement of the Annual General Meeting and thanked everyone for attending.

The Acting Chief Executive/Clerk advised member of the public that recording of the meeting and the taking of photographs are prohibited.

The Acting Chief Executive advised Members of the Board that in accordance with the Local Government Act 1985 is allows for Board Member to attend Board Meetings and vote remotely.

APPOINTMENT OF CHAIR FOR THE 2022/23 MUNICIPAL YEAR

The Acting Chief Executive/Clerk invited nominations for the election of Chair of Onchan District Commissioners for the 2022/23 Municipal Year.

The following nominations were received:-

- 1. Miss Kathryn Williams proposed by Mr D Quirk and seconded by Mr R Turton
- 2. Mr Anthony Allen proposed by Mr D Crellin and seconded by Mr A Allen

Each nominee was invited to make a presentation to the Board.

Mr Allen made the following statement:

"The last year has been a difficult one for the ratepayers and staff of Onchan.

The Board has at times fallen short with weak leadership, poor judgement and bad decisions that have put the Authority at serious risk.

Some Commissioners have lost the respect of both the staff and ratepayers, putting self-interest above duty. Expert, accurate advice has been repeatedly ignored demonstrating a lack of understanding that is unacceptable.

This year I have committed a great deal of time consistently advising the Board that had proven to be correct when facing difficult decisions.

My respect for the staff is mutual and the decisions made have always been in the best interests of the ratepayers of Onchan.

The Chair is an important position within the Authority and when casting your vote do so impartially in the interests of the ratepayers and staff".

Miss Williams made the following statement:

"I have been asked on a couple of occasions to consider standing for Chair, up until this point I have not felt it appropriate to do so. I have 10 years' experience as a Commissioner and it is now time to say if I don't do it now, when will I?

I know it is a commitment and I believe that I can help build on the work of the Board so far. In terms of public perception, there is more work to be done. I believe in the staff and the Board we have. We can work together to build a better Onchan, which is what everyone on the Board has been elected to do. It is important to respect each other given that we all have difference of opinions."

Mr Crellin asked the Chair if he would allow him to speak. The Chair confirmed that Mr Crellin could.

Mr Quirk requested a point of order. The Chair refused.

Mr Crellin made the following statement:

"I am unable to support Miss Williams as Chair, her judgement, together with two other Commissioners at a meeting of the Authority disregarded legal advice. This necessitated the Authority's Legal Advisers attending a special meeting and reiterating the previous legal advice and if not acted upon would put the Authority at risk. They then changed their original vote, confirmed in minutes and caused double expenditure.

It is essential policy and procedures should be followed and standing orders adhered to".

The Chair [ODC 16/05/2022] advised that in accordance with Standing Orders if more than one nomination is received for the position of Chair, voting is to take place by a secret ballot.

The Chair [ODC 16/05/2022] advised the Board that a majority vote had been reached and that the duly elect Chair for the 2022/23 Municipal Year is Miss Kathryn Sian Williams.

The outgoing Chairman, Mr Robin Turton invested the Chain of Office to Miss Williams.

Miss Williams thanked Mr Allen for putting his nomination forwarded and made the following acceptance speech:

"Thank you to the Board for their support.

Thanks to Mr Turton for his work, he will be a hard act to follow.

I know that this is a privilege and I am one of a very few women to have held the position. Given that I have been a Commissioner for ten years I feel ready and experienced enough for the challenge ahead. I don't know what kind of Chair I will be but I do know that no-one gets everything right or wrong. I will do the role to the best of my ability. As a Board, we need to continue to move forward and I am confident that by working together and with the staff we have, we will achieve this and Onchan will remain a great place to live".
